Provide education, per detox protocols, for patients withdrawing from opiates and/or alcohol. Perform initial/daily patient assessments and communicate with treatment team (Physicians, Nurse Practitioners, Physician Assistants, and Therapists) regarding plan of care.

**Suboxone Maintenance:** Conduct individual appointments with patients regarding effectiveness of maintenance medication and compliance with treatment expectations. Collaborate with prescribing providers for on-going Medication Assisted Treatment Plans.

**Health Screens:** Conduct health screening and provide patient education regarding communicable diseases.

**Nurse Training:** Provide Orientation & Training for all above job aspects for new nursing staff.

Initially hired as a staff RN and advanced to Charge Nurse for a 40-bed unit.
